ESCL Essay Prize – Regulations

January 2023

Conditions for participation

- 1. Participants must be either young professionals or students. 'Young professionals' must be no more than 40 years old at the date of submission. There is no age limit for students, who must be registered with a university or professional institution.
- 2. A maximum of two co-authors is allowed for any essay.
- 3. Only papers concerning construction law will be considered. Construction law is widely defined to include the following subject areas, which are provided as examples, not as an exhaustive list:
 - Construction and engineering contracts;
 - Contract administration;
 - Procurement law;
 - PFI/PPP;
 - Professional liability of architects or engineers;
 - Building regulations and control;
 - Construction insurance;
 - Law relating to transfer of buildings and real estate;
 - Torts in construction;
 - Construction disputes and their avoidance/resolution including mediation, dispute boards, arbitration and litigation.
- 4. The essay must be submitted within the period 1 January to 1 July 2023, arriving before 17:00 on 1 July 2023 (see also clauses 8-11).
- 5. The essay must be written in English.
- 6. The maximum length of the essay is 5000 words, excluding references and footnotes/endnotes. Each entry must include an accurate word-count.
- 7. Participants are expected to have read the Statement on Ethics and Malpractice below.

Submission

8. The essay must be submitted within the period 1 January to 1 July 2022, arriving before 17:00 on 1 July 2022. They must be submitted by e-mail in a Microsoft Word Document. The essay should be sent to the secretary of the jury:

Hard copies will not be accepted. An acknowledgment of receipt of the entry will be sent within two working days.

- 9. The following information and documents should be provided together with the essay: the name(s), address(es), telephone number(s), email address(es) and dates of birth of the participants(s);
 - If applicable, the name of the relevant study program, title of the thesis and date of graduation;
 - A form signed by the participant(s) accepting the conditions for participation. This form can be found below.
- 10. Essays submitted without the required information (clause 9) will not be considered.
- 11. The secretary of the jury will send an anonymous version of the essay to the members of the jury.

Evaluation criteria

- 12. In assessing the scientific quality of the essay the jury will evaluate the following aspects of the essay:
 - Originality of the topic;
 - Approach/quality of analysis;
 - Approach/quality of presentation;
 - Interest to construction law and construction professions;
 - Connection with either European law or with the law of more than one European country.
- 13. If only one part of the essay concerns construction law, the jury will evaluate only that specific part.
- 14. The report of the jury will be published on the occasion of the awarding ceremony.
- 15. There will be no correspondence concerning the jury's decision.

Jury

- 16. The jury is chaired by the President of the ESCL who will appoint two other members of the jury.
- 17. The secretary of the jury is E.M. Bruggeman.
- 18. If the jury considers a jury consisting of more than three persons appropriate, the jury can decide to enlarge the jury in that year.
- 19. Previous to the evaluation the jury will not be informed about the mark the essay received.
- 20. A member of the jury whose relative wants to submit an essay will withdraw from the jury.

Prize

- 21. The first prize will be awarded with € 2.500,-.
- 22. The second prize will be awarded with € 1.000,-.
- 23. If the second prize is given to two participants, they will receive € 500,-- each.
- 24. In addition, the jury may award (a) Commendation(s).
- 25. The winners may be invited to submit a (modified) version of their essay for publication to the editorial board of the International Construction Law Review.
- 26. The jury reserves the right not to award all or any of the prizes.

Final provision

27. In cases not covered by these rules, the chair of the jury decides.

Statement on Ethics and Malpractice

By submitting a paper for the ESCL Essay Prize, the author(s) warrant that the manuscript is their own original work. They also warrant that the sources of any ideas and/or words in the manuscript that are not their own have been properly attributed through appropriate bibliographical references and using quotation marks. In case of breach of copyright law/or plagiarism, the entire responsibility rests with the author of the essay. The European Society of Construction Law does not except any liability for infringement by the authors of copyright legislation or plagiarism. If a case of violation of copyright law/plagiarism is discovered, the entry will be rejected. The European Society of Construction Law and the Jury does not accept any liability regarding the author's points of view included in the paper.

The Entry must meet the requirements for editing. The essay submitted must comply with the requirements for writing under the Author Guidelines for European Society of Construction Law Essay prize.

The European Society of Construction Law does not accept entries that have already been submitted in part or in full in an article published or which are described in another article sent or accepted by other electronic or printed publications. Any such entry will be rejected.

Accurate presentation of the primary data

Underlying data (statistical indicators, legal regulations, caselaw, doctrinal opinions, polls and so on) should be represented accurately in the manuscript. Knowingly presenting false or falsified data may be grounds for rejection of the entry. The fabrication of results and the making of fraudulent or knowingly inaccurate statements may lead to rejection of the entry.

Authorizations for reproduction and copyright

Authors are responsible for obtaining written permission to include any images/artwork or documents/texts for which they do not hold copyright in their essays, or to adapt any such images/artwork or documents/tests for inclusion in their essays. The copyright holder must be made explicitly aware that the images/artwork or documents/texts will be made freely available online.

Sources of financial support

Sources of any financial support for research used in an essay (grants, scholarships etc.) should be mentioned in the paper in a footnote on the first page.

Submission of an essay to other institutions/publications

Essays submitted for ESCL Essay Prize purposes may not be offered to other institutions or publications without the consent of ESCL until 9 months after the date of submission.

Copyright protection of the submitted essays

The author(s) of a manuscript agree that if their essay is accepted and is awarded a prize it will be published in the online version on the site www.escl.org and will be freely available without charge to the user or his/her institution. Users are allowed to read, download, copy, distribute, print, search, or link to the full texts of the papers without asking prior permission from the publisher or the author, but subject to the following conditions:

- The name(s) of the author(s) and title must be given and it must be stated that the essay was awarded the ESCL Essay Prize and it was published on the ESCL website and indicate page/pages cited;
- Exact reproduction of the material when it is quoted, used, discussed or multiplied;
- The copyright of the author(s) may not be infringed in any way.

Assumption of Liability Declaration

Authors whose essays have been selected and awarded the prizes will need to complete an Assumption of Liability Declaration that the entry belongs to them, that the sources were quoted correctly, that they did not reproduce material from unauthorized sources and that the essay has not already been presented or published elsewhere.

Discovery of significant errors or inaccuracies in articles published.

Where an author discovers a significant error or inaccuracy in an essay of his/hers that has been judged and published, he/she has an obligation to notify the editors promptly and to cooperate with them to correct it.
